# **Championship Meet information posting deadline (Dec 3)**

Monica moved to extend the championship meet information posting deadline to Dec 12, 2021. Motion Passed

# Championship meets format (Nov 16)-

Monica moved to approve the following changes to championship meets after discussion with the championship meet committee. **Motion PASSED** 

**B** Champs: B time standard must be achieved in the last 18 months (last 3 seasons), Limit entries to 4 per day or 7 total, Time trials subject to entry limits.

**STX Champs**: BB times only and must be achieved in the last 18 months (last 3 seasons), Zone ASC to South meet as they are hosting, Limit entries to 4 per day or 7 total, Time trials subject to entry limits, 400 IM is not an 11-18 event and 11-12s will need the 400 IM NAG time for their age/gender, Remove BB time standard for relay stroke/distance, Limit relays to 3 entries per team per relay event/gender

**STAGS**: Stags time standard must be achieved in the last 18 months (3 seasons), Limit entries to 3 per day or 7 total, Time trials subject to entry limits, 400 IM is not an 11-18 event and 11-12s will need the 400 IM NAG time for their age/gender.

# Policy and Procedure updates (Nov 10)

Chris moved to approve the following two policy and procedure updates. Motion PASSED

- 1) Removing II.C.2, below, in its entirety. This was added in the context of hosts not owing splash fees for national-level meets, and for meets such as TAGS that have their own splash fees. In my opinion, it is outdated, because II.C.1 waives splash fees for meets held in ST but managed by TAGS, TSA, and USAS (generally, TAGS/Sectionals and above meets). As I recall, from many years ago, II.C.2 was added to address a specific situation, which has not come up since then.
- II.C.2. The Board of Directors (BoD) may consider waiving the collection of splash fees for meets hosted by South Texas Swimming when requested to do so by the meet's director at least 45 days prior to the meet's start date. The request must be completed in writing and submitted to the Sanctions Chair, who will forward the request to the BoD for consideration and a vote at its next regularly scheduled meeting.
- 2) As there is no longer a "USAS Convention," I believe that it would be appropriate to change all references to this meeting to the "USAS Annual Business Meeting." It is not clear at this time how a future in-person meeting will operate, so I recommend leaving the travel and reimbursement policies intact, for now, until an update is available from USAS.

# **Reimbursement Policy wording (Oct 27)**

Mindy moved to remove an error in the wording of the athlete assistance policy and procedure by removing the typo "individual". **Motion PASSED** 

X.4.a Eligible days for athlete reimbursement are calculated from the day of the athlete's first individual event to the day of the athlete's last event, plus one day
