Admin Vice chair - Deanna Oliphant

The ad hoc strategic planning committee has wrapped up and the plan was submitted to the board for review.

Senior Vice Chair - Monica Thomason

Proposed Motion to update the P&P.

When time trials are offered, *it is the decision of the host team whether athletes must* be entered in the STSI Championship Meet. They must present their USA Swimming ID card or proof of membership using the USA Swimming Deck Pass app (or a coach may present the club's official, watermarked roster from the USA Swimming club portal) to enter time trials. Qualifying times earned during time trials may not be used for entry into the current STSI Championship Meet.

Current P&P VIII. J

When time trials are offered, athletes need not be entered in the STSI Championship Meet. They must present their USA Swimming ID card or proof of membership using the USA Swimming Deck Pass app (or a coach may present the club's official, watermarked roster from the USA Swimming club portal) to enter time trials. Qualifying times earned during time trials may not be used for entry into the current STSI Championship Meet.

Reasoning for the motion.

It essentially removes the requirement that Time Trials be open to anyone and leaves that decision up to the host. That way they can be offered more without overwhelming the host team.
