Old Business

Weekly BOD meetings April 21 and 28 moved to 11:30 AM.

LSC needs to obtain an attorney before any money is distributed. Jessica Evans and Chris Kjeldsen will be finding someone to help South Texas.

New Business

LSC Roles and Responsibility – only the LSC Chairman should be talking to media on behalf of the LSC. The Board is being mindful of conflicts of interest when making decisions.

Marc Digby made the motion that the LSC provide the following guidance to all member teams: South Texas Swimming expects all member clubs to abide by all guidelines and orders published by the authorities in their respective jurisdictions (city, county, state and national). For the avoidance of doubt, that means if your area is under a 'Stay Home Stay Safe' order, then in-person swim practices or dryland practices with South Texas Swimming member athletes and coaches should NOT be conducted. In jurisdictions where guidance may not be clear, member clubs should not be conducting practices if similar business (e.g. gyms, public pools, community rec centers, etc.) have been closed. South Texas Swimming encourages the use of remote options for general engagement or even dryland workouts to the extent they are practical and safe. Mike Varozza amended the motion to only include the first sentence. Amendment and Motion passed. Mindy Donofrio will email the clubs and post on the website as a reminder.

BJ Allenstein presented the following proposal from the governance committee:

South Texas Swimming will rebate clubs \$20.00 per registered athlete due to the recent pandemic for the 2020 year. This will include athletes who are yearly members of USA Swimming, Inc. and, does not include flex or seasonal athletes.

- Teams would have to request the rebate in writing, or a Google form (request a specific amount)
- There is no team cap
- A rebate of membership as opposed to a specific dollar amount per athlete will remove any ambiguity with for profit vs. non-profit entities (501 c 3) organizations. South Texas Swimming's portion of membership is \$20.00. The remaining amount has already gone to USA Swimming, Inc.
- Requesting team must complete the USAS Safe Sport requirements by August 1, 2020. If a team does
 not complete the requirements, they will be required to pay the fees rebated back to them by
 September 1, 2020.

An amendment was made to change the following: \$20 per registered Premium Year around athlete, \$10 per flex athlete and \$2 per outreach athlete. Amendment passed.

A motion was made to table the original motion until tomorrow. Meeting will be on 4/15/2020 at 11:30 am. Motion Passed.

BJ will resend the proposal to the board with the amendment.

Old Business

Governance Committee Proposal – Amended by BJ Allenstein, and BOD - PASSED

South Texas Swimming will rebate South Texas USA Swimming member clubs based on their athlete and coach membership numbers with USA Swimming as of March 16, 2020 plus \$25 (\$20.00 per registered premium year-round members, \$10 for registered Flex-members, \$2 for registered Outreach members, \$15 for Coach members of USA Swimming, Inc). Unattached members are not eligible. Clubs can request this payment by sending an email to the LSC (or completing a form, if utilized) and indicating the payment details (payee and mailing address). Generally, South Texas Swimming USA Swimming Member clubs must apply for assistance based on club code, not on individual sites. Multi-site/multi-organization clubs must manage the apportionment of application, assistance and payment internally. With guidance from the Finance Committee, the South Texas Swimming Treasurer will make reasonable accommodations (e.g. mailing separate checks) where practical. The deadline to apply for this rebate is July 31, 2020. For teams receiving assistance who have balance due accounts with STSI, the assistance will first be applied to their open balance, and the remainder distributed to the team. All clubs receiving a rebate must complete at least sections 1, 3, and 4 of the requirements for the club's Safe Sport certification by August 1, 2020 and provide documentation of completion. Any club that fails to do so will be required to REPAY the total assistance amount prior to renewing registration of club, coaches, or athletes for 2021.

- Require that all applying clubs certify the following in writing:
 - 1. The club intends to remain in operation with a similar size program in 2020-2021 season (registration in Fall 2020).
 - 2. The funds will be used to retain staff and facilities to support future USA-S programming.
 - 3. The club must provide written documentation that they APPLIED for (or are ineligible for) the U.S. Small Business Administration Paycheck Protection Program assistance from the Government. A copy of their financials or their application is NOT required, but rather some

acknowledgement (email from banker, receipt of application from website, approval of loan from lender, etc.).

Total program funding is \$150K. \$75K comes directly from eliminating National Meet Assistance (\$25K existing savings in SC, \$50K eliminating LC). \$75K funded by Board authorization to use other budget items that don't happen, or investment funds as needed.

Marc Digby and Mindy Donofrio will verify that money goes to clubs and not institution's/organization's general use fund.
